General Rules and Regulations

Rates: Water, Sewer and Garbage are determined by each governing body in the form of Ordinances.

Office hours are 8:00 am - 4:00 pm except for Saturdays, Sundays, and Holidays.

Monthly Bills are mailed on the last day of each month, with total payment **due in our office by the 15th** day of each month to avoid penalties and/or further collection efforts.

If you don't receive your bill by the 5th day of any month, please contact us or review your account online.

Failure to receive bill does not exempt you from monthly payment, late charges or disconnection of service.

Cut Off Date is generally 5 to 7 days after the 15th of each month.

**Please Pay Before the Cut-Off Date – We Do Not Extend Payment – No Exceptions. **

Outside payment drop boxes (front door & parking lot) are available for payments made after hours.

We accept cash, checks and money orders in office.

We accept most debit or credit payments through our website only, with a convenience fee applied.

We offer **automatic bank draft** by written authorization. Your bill is drafted from your bank account on or about the 8th day of each month.

Mail - Please allow additional days for postal delivery of your payment to reach our office.

Deposits must be paid in full before service is connected.

Residential/small business customer deposits are \$125.00.

Restaurant customer deposits are \$200.00.

Car Wash/Laundromat/Greenhouse customer deposits are \$250.00. Any other category will be left to the discretion of office staff or management.

Deposit will be waived if proof of ownership is established (Deed or Settlement Agreement)

Please call our office at 270-692-2491 if you are having repairs made, for example replacing a sink or toilet, and our service department personnel will disconnect/reconnect the water at no charge - during normal business hours - while you are having repairs done. If *emergency* repairs are required after normal business hours, please call the Lebanon Police Department at 270-692-2121.
